**SPECIAL CONDITIONS RELATED TO THE COVID-19 EPIDEMIC  
VALID DURING  
2021 WYSOKA GRZĘDA BAJA DRAWSKO POMORSKIE**

Due to the extraordinary situation concerning the COVID-19 epidemic, the participation in the 2021 Wysoka Grzęda Baja Drawsko Pomorskie (hereinafter referred to as "the Competition") will be carried out in accordance with special sanitary requirements.

This document sets out basic recommendations and safety requirements related to participation in the Competition to reduce the risk of infection during the COVID-19 epidemic in Poland.

**PARTICIPANTS**

As a person taking part in the Competition, he or she is considered: Competitor, Crew Members, persons accompanying the Competitor/Crew members (e.g. mechanics), representatives of accredited media and Officials, marshals and organizer's staff.

**DANGERS**

- risk of contact with a COVID-19 infected person;
- risk of COVID-19 infection.

**AIMS**

- minimize the risk of transmission and COVID-19 infection during participation in the Competition

**ACTIONS**

- Limitation of interpersonal contact (e.g. On-line Administrative Checks)
- Limiting the grouping of people (e.g. Briefing On-line, press conference in the form of individual interviews on fresh air);
- applying the obligation to keep a social distance (min. 1.5 meters) and to cover the mouth and nose;
- Regular use of disinfectants;
- body temperature control.

**MEASURES**

- Providing personal protective equipment (PPE) for officials, marshals and organizer staff (masks, visors, gloves);
- providing disinfectants in the facilities and places used by the organizer (i.e. the Competition Office, Press Office, Scrutineering/Final Checks, Marshal Posts)
- Providing adequate space for the Participants, allowing them to maintain the required social distance and preventing people from grouping together (e.g. distances in the Service Park, presentation of the crews, the Finish Ceremony and the Rally HQ)

### **RULES OF PARTICIPATION**

In accordance with the applicable law, the Competition takes place without the participation of the public, so spectators zone will not be provided by the Organizer.

Before taking part in the Competition each Participant must inform the Organizer about his/her current health condition and possible health contraindications to participate in the Competition.

For this purpose, each Participant is obliged to complete a health declaration on the form provided by the organizer and, if necessary, also undergo a non-contact body temperature test, which will be carried out by the organizer's staff. The test result will be recorded in an appropriate protocol.

In case of obtaining a temperature above 38° C or refusing to undergo the above mentioned non-contact body temperature test, the person will not be allowed to further participation in the Competition and the fees paid will not be returned.

All Participants are required to follow these guidelines and procedures:

- each Participant must read this document;
- each Participant undertakes to comply with the provisions of this document, the Regulations of the Competition, the Regulations of the facilities and areas where the Competition takes place and the generally applicable law;
- each Participant undertakes to submit to the instructions and guidelines of the Organizer's staff and the staff of the facilities and areas where the Competition takes place;
- Only admitted Participants are allowed to stay in the Competition area;
- it is recommended to limit the competitors' personnel to the necessary minimum;
- Participants are obliged to stay in designated places, use only designated routes and observe the rules of keeping social distance, in particular, keeping social distance and gathering in max. groups of 5 people;
- Participants are prohibited from unnecessarily grouping together and moving between teams, competitors and designated areas;
- Each Participant must have their own personal protective equipment (in addition to that provided by the organizer) and maintain the required social distance. It is obligatory to use masks covering the mouth and nose throughout the whole time of competition (this obligation does not apply to competitors during sports activity on the route of special stages). The use of protective gloves is recommended;
- each Participant must have their own disinfectants (except those provided by the organizer), and disinfect hands and sports equipment owned by them;
- each person is obliged to disinfect their hands with disinfectant and repeat this activity according to the guidelines of the Organizer's staff and the staff of the facilities and areas where the Competition takes place.

The Participant is responsible for the proper training and safety of himself and his accompanying persons during the Competition.

**STATEMENT**

With this signature I declare that:

- I waive, to the fullest extent permitted, my rights to any and all claims for any losses and/or damages and/or harms that may occur during the Competition to myself and my accompanying persons. This waiver applies to the Organizer, the Organizer's staff members, the owners and staff of the facilities and areas where the Competition takes place, and other Participants who have been registered.
- I agree to the processing of my personal data by the Baja Poland Foundation (Personal Data Administrator) pursuant to Article 6(1)(a) of Regulation (EU) 2016/678 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).
